External payment order for transfer received on the non-working day shall be considered as received on the Bank's following working day and shall be executed on this day. The only exception are the instant orders which shall be effected immediately after reception, since they are received electronically, through the office banking, home banking and m-banking any time of day, any day of a year (24 hours/7 days a week/365 days of a year).
